J. Brown his wife of the County of Southampton and State of Virginia of the one part and Edwin Bland
of the County and State aforesaid of the other part Witnesseth that the said Orris & Brown and Susan
his wife for and in Consideration of the sum of One hundred dollars to them in hand paid receipt
whereof is hereby acknowledged both by signature and Seal and by these presents doth bargaine and alle
unto Edwin Bland husband of a certain tract or parcel of Land lying and being in the County aforesaid
said land bounded as follows Beginning at the fork of the Jerusalem and Haley's Bridge
Road near Said Bland's house thence with said Haley's Bridge Road to corner of Jones line
thence East with said Jones line to George Gray's line thence thence with said Gray's line to
the Jerusalem Road thence west with said Road to the Beginning before stated in County and
be the same more or less to have and to hold the said bargaining premises with all and
singular the appurtenances therunto belonging or in any way appertaining to the only
possession and belief of him the said Edwin Bland his heirs or assigns theright
and title of said land we warrant and defend against the claims or demands of all and
every person or persons with whomsoever of us have hereunto set our hands and seals
