James McCall This Indenture made this 9th day of August 1832 Between Oris A Brown and Susan his wife of the County of Sanhampton and State of Virginia of the one part and Edwin B. Land of the County and State aforesaid of the other part. Witnesseth that the said Oris A Brown and Susan his wife for and in Consideration of the Sum of one thousand dollars to them in hand paid the receipt whereof is hereby acknowledged both here and sold and by these presents do the said Susan and all unto Edwin B. Land his heirs &c a Certain tract or parcel of Land lying and being in the County aforesaid and bounded as follows. Beginning at the fork of the Jerusalem and Haley's Bridge Road near said Land's House thence with said Haley's Bridge Road to Francis J. Jones line thence East with said Jones line to George Ingle's line thence at right angles to the Jerusalem Road thence West with said Road to the Beginning supposed to be a corner and to be the same more or less To have and to hold the said &c a Certain premises with all and singular the appurtenances thereto belonging to him or any heirs appertaining to the only proper use and behoof of him the said Edwin B. Land his heirs or assigns the right and title of said Land we demand and defend against the claims or claims of all and every person or persons.
