Brown to the said Stephen Murdaugh at and before the executing and delivering of these presents the receipt whereof is hereby acknowledged the said Stephen Murdaugh with the assent and approbation of the said James Murdaugh signed by his being party to these presents and the said James Murdaugh have granted sold conveyed bargained and sold promised released and confirmed, and by these presents do grant bargain and sell promise release and confirm unto the said Orris A. Brown all the estate right title interest claim and demand that at Law or in Equity which the said Stephen Murdaugh and James Murdaugh have or hold in or to the Land To have and to hold the said tract or parcel of Land to the said Orris A. Brown his heirs Executors administrators and assigns forever to the only proper use and behoof of the said Orris A. Brown his heirs Executors administrators and assigns forever and to the said Stephen Murdaugh and James Murdaugh for themselves their heirs Executors and administrators the above mentioned Land unto the said Orris A. Brown his heirs Executors administrators and assigns in as full and ample manner as the same was warranted by the said Orris A. Brown by the Deed of Trust above recited do covenant the same to the said Orris A. Brown against the claims or claims of them the said James Murdaugh and Stephen Murdaugh and all persons claiming by or under them or either of them.
