bargain and sell to the said Orris & Brown  
all the estate right title interest claims and demands both at law and in equity  
which the said Stephen Munday and James Munday have or hold in  
in the Land To have and to hold the said tract or piece of Land to the said Orris &  
Brown his heirs Executors administrators and assigns for ever to the only proper use and benefit
