This Indenture made the 25th day of August in the year of our Lord one thousand Eight hundred and Thirty two Between Hanit Bailey of the County of Sutherland and Parish of Kildonan of the one part and John Holliman of the same County and Parish of the other part witnesseth that the said Hanit Bailey for and in consideration of the sum of Six dollars gross and lawful money of Margarita to him on hand paid by the said John Holliman the receipt whereof the said Hanit Bailey doth acknowledge his self fully and completely satisfied and paid him granted bargains sold alured entreated and confirmed and by these presents doth grant bargains and sell unto the said John Holliman his heirs and assigns forever one certain tract or parcel of land and premises situated lying and being in the County aforesaid containing by estimation two acres to be the same more or less and bounded as follows tract Beginning at the centre of the road called Proctor road the corner of John Holliman's fence running Eastward to a Stake at the fence called a corner stone Sustained by a Posternum tree sapling a corner stone set to the said Proctor Road thence standing said Road to the beginning. Together with all houses out houses edifices buildings yards gardens orchards meadows waters and water courses whatsoever belonging or in any wise appertaining thereto. To have and to hold the said Land and premises to him and to his heirs forever And the said Hanit Bailey for himself his heirs &c doth by these presents covenant and grant he and will the said John Holliman his heirs and assigns that he will by these hands warrant and forever defend all right title claim or demand of any person or persons claiming or demanding the same or any part thereof & shall keep clear of the said Hanit Bailey his heirs and assigns to him and affix her seal the day and year above written Signed sealed and acknowledged.
