hereunto annexed personally appears before us in our County aforesaid and being examined by us touching  
and apart from her husband and having the said affidavit fully explained to her she the said  
Martha Jones acknowledge the same to be her act and true and declare that she has  
voluntarily signed sealed and delivered the same and that she desires not to retract it

This Indenture was acknowledged by Thomas L Jones and together with the Certificate  
thereunder of his free examination and relinquishment of Power of Master Jones wife of the said  
Thomas L Jones party thereto admitted to Record And at a Court held for the County aforesaid  
the 17<sup>th</sup> day of September 1832 The said Indenture was witnessed and acknowledged this day.

Willows This Indenture made this 29<sup>th</sup> day of August and in the year of our Lord one thousand Eight hundred  
and Thirty Two Between James B Willows Trustee of the sum part and Holliday Morton Debtor of the  
Mortion sum part and Wilson Willows Creditor of the this part Whereas the said Holliday Morton  
on the 13<sup>th</sup> day of April last or about that time in Order to secure the payment of the sum of one  
hundred and Twenty dollars to the said Wilson Willows did by Indenture of Trust of the said  
County to the said James B Willows his heirs & on the first day of October yearly and for ever  
paid of land lying and in the County of Southampton upon trust for the uses and purposes  
in the said indenture mentioned and whereas since the executing and delivering of the  
said Deed of Trust the said Holliday Morton hath fully satisfied and paid to the said  
Wilson Willows the sum and before mentioned which the said Wilson Willows doth hereby  
acknowledge Now this Indenture witnesseth that for and in consideration aforesaid  
as well as for the further consideration of one dollar and half pence by the said Wilson  
Willows to the said James B Willows Trustee and before the sealing and delivering  
of this presents the receipt whereof is hereby acknowledged by the said James B Willows  
Trustee with the intent and apprehension of the said Wilson Willows signifying his  
being party to these presents and the said Wilson Willows hath granted bargained  
and sold remised released and confirmed by these presents do grant bargain  
and sell remise release and confirm unto the said Holliday Morton all the estate right  
title interest claim and demands both at Law and in Equity which the said James  
B Willows and Wilson Willows have or hold in the land aforesaid To have and to  
hold the said tract or parcel of Land to the said Holliday Morton his heirs &  
admits and agrees forever to the only proper use and behoof of him the said Holliday  
Morton his heirs & assigns and agrees forever to the said James B Willows and Wilson  
Willows his heirs & assigns the above mentioned Land unto the  
said Holliday Morton his heirs & assigns a full ample manner and  
same uses & unaniates by the said Holliday Morton by a Deed of Trust above recited  
so remain the same to the said Holliday Morton against the claim or claims of
