This Indenture made and entered into the 16th day of November one thousand and thirty two between Nathaniel Cherry of the first part, Egerton Soyner of the second part and Benjamin Rochelle of the third part all of the County of Southampton State of Virginia Witnesseth that whereas the said Nathaniel Cherry stands jointly indebted to the said Egerton Soyner in the sum of seventy five dollars by note bearing the same date with this present writing and the said Nathaniel Cherry being willing and desirous to secure the payment of the said sum of money to the said Egerton Soyner, doth sell well for and in consideration of the promises as for and in consideration of the sum of one dollar to him in hand paid by the said Egerton Soyner at or before the making and delivery of these presents the receipt whereof is hereby acknowledged and bargained and sold, and by these presents doth give and bargain and sell unto the said Egerton Soyner the following property, Wit One Cart and wheel and gear one Bow and ten shears, one plough, two plough hoes, one Cutler, three cutting hoes, one hair iron wedged, two axes, one pair of flat irons, one pot, one pump, two shillings, one Spider, one putrack, and Hooks, one head hoe, two further beds bed heads and furniture, four sitting chairs, one spinning wheel and Cards, one tub, one pair three trays one pine table, one dish, one dozen plates, one set Cups and saucers, one Case knives and forks, one Coffee and one tea pot, sugar dish and milk pot, one set table spoons, one set tea spoons, three bowls, nine black bottles, two Pickles, one decanter, three pitchforks, one demijohn, two canteens, one hand saw, one draw knife, one steel gun, one set shoe makers tools last bend of C. one Stewer hook and grubbing hoe, one tin trunk, Crop of Corn fodder pens &c. and one thousand wheel together with all its promises and appurtenances and every part thereof. with the said Egerton Soyner his heirs and assigns forever. It is covenanted upon this End that the said Nathaniel Cherry pay or cause to be paid unto the said Egerton Soyner his heirs or assigns on or before the 1st day of December one thousand and thirty three the aforesaid sum of money with interest in all case in cases then the above Allegations to be said and of no effect. But should the said Nathaniel Cherry fail to pay unto the said Egerton Soyner the aforesaid sum of money with interest and Costs when the same required then and in that case it shall be lawful for the aforesaid Benjamin Rochelle who is mutually chosen as Trustee to proceed to sell after giving lawful notice by advertisement the aforesaid property or so much thereof as may be sufficient to pay the aforesaid sum of money with interest and all cost incurred into the said Egerton Soyner and the balance if any to the said Nathaniel Cherry from this obligation.
