Mugabut This Indenture made this 27th of December in the year 1832 Between Richard Mugabut
and his son and daughter R Edwards of the first party John Mugabut of the second party and James
Gray of the third party Wethersfield that whereas the said J R Gray having by Deed
made and Seal of Record in the County of Suffolke County is in Possession to the said Richard Mugabut
and to his son and daughter R Edwards for the benefit of John Mugabut the interest which the
said Gray has in a certain tract of land in the County of Suffolk known by the name
of the Spring Swamp planted in and the said Gray having therewith the said land in
his hands given for the debt for which the said land was Surveyed in trust in
accordance of the said Mugabut to release to him the said interest in the Spring
Swamp which he the said Gray holds in his own right and also the interest he
has in the plantation formerly belonging to his brother Edesew Gray which are the interests
as aforesaid of another Indenture Wethersfield that for and in Consideration of the sum of
as aforesaid and for and in Consideration of the sum of four dollars paid by them therefore
Richard A Mugabut, and his son and daughter R Edwards to them in hands paid by the said J R
Gray at or before the signing, and delivery of these presents, the receipt whereof is hereby
acknowledged, hath granted, bargained, sold, released, and remitted to the said Gray,
and to his son and daughter R Edwards all the right title
and interest in and to the said lands or interests in the said Spring Swamp, plantation
known by the said Gray his heirs and assigns forever and the said Richard A Mugabut
and his son and daughter R Edwards for themselves their heirs, executors, &c well and truly for ever
quit and defers to the said Gray the aforesaid interest in the Spring Swamp plantation
against the claim of them the aforesaid Mugabut and Edwards, or all and every person
persons claim, by or through them. In witness whereof the parties of the first part and
