Middletown This Indenture made this 21st day of May in the year 1832 between Aaron Middleton
 of the first part Fidelity Sellahone of the second part and Thomas A. Newsum of the third
 part Whereas the said Fidelity Sellahone on the 2nd day of May in the year 1832
 to secure the payment of ~~Five hundred and~~ four hundred and twelve dollars and ten cents
 to the said Thomas A. Newsum did by Indenture of that date convey to the
 said Aaron Middleton his heirs Executors and administrators the following property to wit
 One hundred acres of land more or less adjoining the town of Milledgeville in the County of
 also One other tract of Land containing two hundred and fifteen acres more or less adjoining
 the lands of Alexander Ellegree in the said County also One other Tract of land containing
 One hundred and seventeen acres more or less lying in the County of Horry in the State
 of North Carolina, also an undivided share or interest in a certain tract or parcel of
 land containing by estimation three hundred and Eighty acres formerly the property of
 Williams the decedent together with the following personal property to wit
 four hundred twelve Cattle One yoke of oxen Ten only Sheep and Ridden Horses and
 to give hundred dollars upon trust for the uses and purposes in the said Indenture
 mentioned and whereas since the executing and delivering of the said Recd of Trust
 the said Fidelity Sellahone hath paid, satisfied and paid to the said Thomas A. Newsum
 the said sum of money thereby secured so that the said Thomas A. Newsum do hereby
 acknowledge that the said Indenture with respect to that for the consideration of money
 as well as for the further consideration of One dollar in hand paid by the said Fidelity
 Sellahone to the said Aaron Middleton at and before the executing and delivery of the
 for which the receipt whereof is hereby acknowledged by the said Aaron Middleton
 the agent and approbation of the said Thomas A. Newsum signified by his signature
 to these presents and the said Thomas A. Newsum have granted bargain sold conveyed
 released and confirmed and by these presents do give and bargain and sell convey
 release and confirm unto the said Fidelity Sellahone all the estate right title and
 claim and demand that at Law and in Equity which the said Aaron Middleton and
 Thomas A. Newsum have or hold in the lands and personal property above described
 To have and to hold the said Tract or parcels of Land together with the above said
 property to the said Fidelity Sellahone his heirs administrators and assigns forever
 the only proper use and behoof of them the said Fidelity Sellahone his heirs Executors
 administrators and assigns forever And the said Aaron Middleton and Thomas A. Newsum
 for themselves their heirs Executors and the above mentioned lands and personal property
 unto the said Fidelity Sellahone his heirs Executors administrators and assigns in full
 and ample manner as the same was warranted by the said Fidelity Sellahone
 the Word of God also written do warrant the same to the said Fidelity Sellahone
 against the claim or claims of them the said Aaron Middleton and Thomas A. Newsum
