This Indenture made and entered into this the 20th day of June 1833 between
 R. Edwards of the one part and Samuel Kells of the other part both of the County of
 Santhampton Whereas the said Samuel Kells on the 15th day of October 1832 was indebted
 to secure the payment of the sum of four hundred and seventy two dollars and twenty cents
 to Robert Goodwin by Indenture of Trust of that date coming to the said
 R. Edwards his heirs and assigns the following property to wit All the several tracts
 or parcels of lands to which the said Kells was entitled lying in the County of
 Santhampton State of Virginia and in the County of Stafford for to the said
 One half of the mill and land attached to it known as Richman's inform property
 chased jointly by Robert S. Goodwin and the said Samuel Kells also a tract of
 land adjoining the said mill Pond containing one hundred and thirty seven
 or less also a tract or parcel of land adjoining the lands of Ben. Cobb and Eliza
 Price and situated between and lying between the road leading to Smithfield
 Cobham and the mill Pond before mentioned containing one hundred and twenty
 or less also one other tract or parcel of land lying in the County of Stafford
 Carolina adjoining the lands of Elias Warden. John Price and Clements Price
 and known as a part of the land formerly belonging to Will. Beauchamp
 containing two hundred acres more or less likewise three beds and furniture two beds
 half a dozen chairs Glass &c. China &c. upon trust for the uses and purposes in the
 said Indenture mentioned And whereas since the executing and delivering
 of this said deed in Trust the said Samuel Kells has fully satisfied and paid
 sum of money thereby secured. At on this Indenture We agree that the
 Considerations aforesaid as well as for the further sum of one dollar and
 cents paid by the said Samuel Kells to the said Trustee R. Edwards
 receipt whereof is hereby acknowledged by the said Trustee R. Edwards
 granted bargained and sold Remised released and Confirmed and by the said
 deed granted bargained sell Remised released and Confirmed unto the said Samuel
 all the Estate right title interest claim and demand both at law and in equity
 which the said Trustee R. Edwards has or holds in the lands and profits
 above described To have and to hold the said land and other property to the said
 Samuel Kells his heirs Executors administrators or assigns forever to the only purpose
 use and behoof of him the said Samuel Kells his heirs Executors administrators
 assigns forever And the said Trustee R. Edwards for himself his heirs
 and assigns the above mentioned land and other property unto the said Samuel
 Kells his heirs Executors administrators or assigns in as full and ample manner
 the same was warranted by the said Samuel Kells by the Deed of Trust
 recited do warrant the same to the said Samuel Kells against the claims
