one certain lot or parcel of Land lying and being in the town of Somersham together with
all the buildings and improvements thereon and its appurtenances of every kind whatsoever
it being the same property of which W^t Hart due Seizid and which was afterwards sold by
Charles & Mingofield Marshall of the Superior Court of Chancery for the Williamsburg
District by virtue of a Decree of said Court at which sale said property was bought by
Joseph & Henderson and by him Conveyed to said Nicholson all of which will more
fully appear reference being had to the Clerks Office of Southampton County Court
Also one tract or parcel of Land lying and being in Southampton County containing
164 acres more or less together with all the buildings and improvements thereon and its
appurtenances of every kind whatsoever it being the same allotted to said Richard & Nich-
olson in the division of the Estate of his father Richd Etchelton dec^d all of which will
more fully appear by reference to Report of Commissioners of Southampton County also one
other tract or parcel of Land containing 174 acres be the same more or less lying and
being in said County with all the buildings and improvements thereon and its appurtenances

to be sold the property hereby Conveyed at public Auction to the highest bidder having previously
fixed the time and place of Sale and given notice thereof for twenty days Accepting now
or more of the stampers public bid and Tetring either for cash in whole or in part
or on such credit as said debtors or either of them or their Executors or Administrators
