 to Mills & Lawrence jointly indebted to the said John Lawrence in the sum of five hundred and four dollars
 money six dollars to be paid the 25th day of August Eighteen hundred and thirty three
 Bond bearing date on the 16th day of August 1833 with legal interest thereon accruing
 Solomon Example is willing and desires to save. Now this Indenture Witnesseth
 that for and in consideration of the premises and also for the further consideration of
 of lawful money of Virginia to the said Solomon Example in hand paid by the said
 Lawrence at and before the sealing and delivery of these presents the receipt whereof
 acknowledge the said Solomon Example hath given granted bargain'd & sold
 conveyed released and confirmed and by these presents doth give grant bargain'd
 conveyed released and confirmed to the said Mills & Lawrence his heirs and assigns
 the following property to wit. One tract of land lying in the County of Southampton
 by the most ancient Mites and bounds beginning at a Cypress corner Tree of Thomas
 and Solomon Example thence along a straight line of marked trees to Eighteen feet
 Solomon Example thence a straight line of marked trees to pine a corner tree of
 and thence along a line of marked trees to Sea cock Swamp thence down
 to the first station containing by estimation One hundred and twenty five acres be the same
 or less also two negroes named and being fifty barrels of Corn three thousand
 blades of fodder twenty five head of hogs six head of Cattle and bay horse &c with all
 singular the appurtenances in any wise appertaining and all the right title
 interest of the said Solomon Example in and to the said granted or intended
 hereby granted To have and to hold the said property above mentioned
 unto the said Mills & Lawrence his heirs and assigns forever to the
