This Indenture made and entered into this Eighth day of August one thousand Eight hundred and thirty three Between Peter Edwards of the County of Southampton and State of Virginia of the one part and David Harris of the County and State aforesaid of the other part. Witnesseth that the said Peter Edwards for and in consideration of the sum of Nine hundred and forty dollars and more and a half Cents to him in hand paid the receipt whereof is hereunto acknowledged in or before the Sealing and delivering of these presents which granted bargain and sell and confirmed hereby these presents doth grant bargain and sell and Confirm to the said David Harris his heirs and assigns forever One certain tract or parcel of land containing one hundred and seventeen acres lying and being in the County and State aforesaid and on the south side of Angelen Swamp and long part of the old Hills land and bounded as follows to wit beginning at an oak tree in the Edge of Harris' Mill Pond or Angelen Swamp in said Harris' land thence running nearly in a westerly direction along said Harris' line to the land formerly owned by Michael Harris and now belonging to the said David Harris thence along the said line of the Harris land to a corner tree a pine in said line thence nearly in a westerly direction to a pine thence to a post oak thence to a small white oak in the fork of a small branch thence down the said Branch to a poplar through an old dam thence by a corner of Chopped trees to a paper fence in the Edge of Harris' Mill Pond or Angelen Swamp thence down said Swamp to the Beginning. To have and to hold said One hundred and seventeen acres and all the appurtenances thereto belonging to the said David Harris his heirs and assigns forever to the only purpose and behoof of him the said David Harris his heirs and assigns forever. And the said Peter Edwards for himself and his heirs doth hereby warrant and defend the title to the said land and promises to the said David Harris his heirs and assigns against the claims or claims of all persons whatsoever.
