This Indenture made this 12th day of March in the year one thousand eight hundred and thirty three between James Gee and Hannah his wife of the County of Halifax and State of North Carolina of the first part and James M. Bragg and Jones Mordecai and Osborne of the Town of Petersburg Virginia of the second part Witnesseth that the said James Gee and Hannah his wife for and in consideration of the sum of Twenty five Dollars to them in hand paid or to be paid by the parties of the second part the receipt whereof is hereby acknowledged, hath granted bargained and sold unto the said James M. Bragg and Jones Mordecai and Osborne a certain tract of land, lying and being in the County of Southampton and State of Virginia on the Appomattox River known by the name of the land and containing by deed from Minton and wife five hundred and some or less acres bounded by the land belonging to the heirs of Dr. David Anderson, by the lands of the possession of William L. Powell, the lands of Miss Harriet Thomas of the land of John H. Pison to the River thence up the River to the beginning of the land and singular the appurtenances thereto belonging or in any wise appertaining To have and to hold the said tract of land of five hundred and some or less with all its appurtenances unto the said James M. Bragg and Jones and Mordecai and Osborne their heirs and assigns forever free from all claims and incumbrances and the said Gee and wife for themselves their heirs executors administrators agree to and with the said James M. Bragg & Jones and Mordecai and Osborne their heirs &c. to warrant and defend the title to said land in fee simple against the claim of all persons or persons who shall come. In Witness whereof we the undersigned have hereunto set our hands and seals the day and year first above written.

We do hereby certify that we have this day the selling instrument of Hannah wife of James Gee to a tract of land sold by said James Gee and wife to James M. Bragg and Jones Mordecai and Osborne of the Town of Petersburg State of Virginia with deed hereto date 12th March 1833 and herunto annexed and the said Hannah Gee doth hereby acknowledge her signature to said to be her hand and seal set and seal and that she signed the same freely and voluntarily without the force or threats or her husband and that she is willing the same be recorded in the Court of Southampton State of Virginia.
