Gray Trusting To West. This Indenture made this first day of March in the year of our Lord Eighteen
 and thirty four Between Thomas R. Gray of the first part William West of the second part
 John Megachant of the third part: Whereas the said William West on the day
 to claim the payment of the sum of \$1000 to the said John Megachant did by indenture of
 of that date convey to the said Thomas R. Gray his heirs &c. the following property to wit
 the plantation whereon the said William West now resides containing by estimation one hundred and
 three and a half acres be the same more or less and bounded as he is set out in the said Dec of Trust aforesaid
 all the chattels Estate upon Trust for the uses and purposes in the said indenture mentioned and
 since the executing and delivering of the said Dec of Trust the said William West had fully paid
 and paid to the said John Megachant the several sums of money thereby secured which the said
 John Megachant doth hereby acknowledge from This Indenture Wherefore that the said
 aforesaid as well as for the further consideration of one dollar in hand paid by the said William West
 to the said Thomas R. Gray at and before the executing and delivery of these presents the said
 is hereby acknowledged by the said Thomas R. Gray with the assent and approbation of the said
 Megachant, signified by his being party to these presents and the said John Megachant having
 longanized, sold, removed, released and confirmed and by these presents do grant longanize and
 release and confirm unto the said William West all the right title interest claim and demand
 both at Law and in Equity which the said Thomas R. Gray and John Megachant have or shall
 in the above described property. To have and to hold the said property to the said William West
 his heirs &c. forever to the only proper use and behoof of him the said William West his heirs
 &c. forever. And the said Thomas R. Gray and John Megachant for themselves their heirs
 aforesaid property unto the said William West his heirs &c. in as full and complete manner as
 the same was warranted by the said William West by the aforesaid Dec of Trust do warrant the
 same to the said William West against the claim or claims of him the said Thomas R. Gray
 and John Megachant and all persons claiming by or under them or either of them. All which
 to him of the parties to these presents have hereunto set their hands and affixed their seals
 and gave first above written.
