This Indenture made this 23rd day of February 1834 Between Joseph H Parker
and John M Teller Commissioners appointed under a decree of the County Court of Southampton
of the one part and Solomon D Parker of the other part. Metrepech that the said Joseph
Parker and John M Teller Commissioners in Consideration of the sum of Eight hundred
of lawful Money of this Commonwealth to them in hand paid by the said Solomon Parker
at and before the sealing and delivery of these presents the receipt whereof is hereby acknowledged
have bargained and sold and by these presents do and each of them doth buy and sell
unto the said Solomon D Parker his heirs and assigns a certain tract or parcel of land in the
County of Southampton containing Nine and a half acres and bounded as follows Beginning
at Red oak at Butts Road thence along a line of marked trees to a pine a corner in the line
of the Estate of Richard P Clements thence along said Clements line to Butts Roads
thence along a line of marked trees or Butts old Road to the beginning together with all
singular the appurtenances unto the said tract or parcel of land or in anywise appertaining
or belonging to have and to hold the said tract or parcel of land with all and singular
appurtenances unto the said Solomon D Parker his heirs and assigns forever to and for the
only proper use and behoef of him the said Solomon D Parker his heirs and assigns
And the said Joseph H Parker and John M Teller Commissioners for themselves and theirs
the said tract or parcel of land with all and singular the premises and appurtenances
before mentioned unto the said Solomon D Parker his heirs and assigns free from all claim
or claims of them the said Joseph H Parker and John M Teller Commissioners either
themselves or either of their heirs and of all and every person or persons whatsoever shall
will and do warrant and forever defend by these presents In Witness whereof the said
Joseph H Parker and John M Teller Commissioners have hereunto set their hands and
sealed the day and year first above written

This Indenture made this 12th of July 1834 Between J R Gray (Foster) of the first part
and John H Mann of the second part all of the County of Southampton Metrepech that a certain
S P Park late of the County of Southampton died by Death of tract dated the 29th of October 1833
and of Record in the Clerks Office of Southampton County to the said J R Gray as Trustee
for himself and his wife and for his son S P Park and his wife and for his daughter
and her husband and for his son in law and his wife and for his daughter in law and
their spouses therein named Considerable Real and Personal Estate which will appear by reference
to deed afterwards among which property then owned was all the said S P Park's real
interest right title or demand which he the said S P Park had in and to the said
property to Park lately then do & will directions in said Deed when the said Gray
is thereto required to be present he shall after giving legal notice thereof proceed to sell the same
the sum of Fourteen for Cash to the highest bidder notwithstanding Indenture Metrepech
pursuant to said Deed the said Gray trustee having advertised according to law the same
