

Oct 19/1835

This Indenture made and revised into this 15<sup>th</sup> day of December in the year of our  
Christ One thousand eight hundred and thirty four Between Benjamin Lewis of  
the County of Southampton in the State of Virginia of the one part, and Samuel  
of the said State of the other part; Witnesseth that the said Benjamin Lewis of one part  
to Henry Raw of the other part, for and in full satisfaction of the sum of Three hundred and eighty seven dollars to him in hand paid  
and before the execution of these presents, the receipt whereof is hereby acknowledged  
granted, buy and sell, and by these presents doth grant, buy and sell unto the said  
and bring in the said County of Southampton containing by actual survey  
hundred and twenty nine Aers, and bounded as follows in the annexed plan  
same it being all the said Lewis's land lying north of the road leading to Green  
the Adams tract together with all and singular the appurtenances unto the said  
and Rollings his heirs and assigns To have and to hold the said land with the  
tenures thereunto belonging unto the said Samuel Rollings his heirs and assigns  
forever and the said Benjamin Lewis for himself and his heirs, hereby Covenant  
that he will warrant the title of the said land, against himself his heirs and  
utors, and administrators and against all and every person and persons whatsoever  
the said Samuel Rollings his heirs and assigns forever by these presents In Witness  
whereof the said Benjamin Lewis hath hereunto set his hand and affixed his  
Seal the day and year first above written -

Surveyed for Benjamin Lewis the above tract of land lying in Southampton County on the north  
the Road containing 129 Aers Situate and Bounded as follows (to wit) Beginning on the Road at a corner  
David Prince and said Benjamin Lewis thence along said Road adjoining said Benjamin Lewis and  
William Prince corner along his line N 59° 44' 29" poles N 29° 44' 19" poles N 55° 44' 57" poles to a corner  
said Branch as it runs to a short gum corner to the side of James Goyard dec. along said line  
S 65° 1/2 E 29 poles S 74° E 59 poles S 77° E 34 poles S 61° E 57 poles to a point S 75° E 71 poles to an oak on a Branch  
Branch as it runs to a Black Gum at the junction of another Branch up said Branch at  
to a Black Gum at its head then a Spring corner on David Prince's line along his line S 70° W  
N 36 poles to a point S 5 E 54 poles to the Beginning
