This Indenture made the 13th day of January in the year of our Lord One thousand
and eight hundred and thirty five between Calvin J Petherson and Mary his wife
of the County of Southampton of the one part and Joel Proffers of the said County of Southampton
part 100 acreth that the said Calvin J Petherson and Mary his wife for and in
consideration of the sum of Thirty nine dollars twenty Cents to them in hand paid or
summa to be paid by the said Joel Proffers before the mailing & delivery of these
proposals, the receipt whereof is hereby acknowledged. Now Whereas of late and by
her present so hereby bargain & sell unto the said Joel Proffers One certain tract
a parcel of land lying and being in the County of Southampton containing by
ancient Survey Thirty Acres to the same more or less and bounded in the following
manner to wit Beginning in the middle of the road in the rear of the branch near
said Proffers former Thence down said branch to its junction with the Young Branch
thence up the said Young Branch an east course to the main road thence along the
same a north course to beginning. To have and to hold the said land and Tenements
with all the appurtenances unto the said Joel Proffers his heirs and assigns forever.
