The Condition of the above obligation is such that whereas the above named Lillien R. Edwards hath been by the Court of Southampton County appointed a Clerk of the said Court for and during the term of seven years next ensuing. Now of the said Lillien R. Edwards shall faithfully account for and pay unto the said public Treasury in the manner prescribed by law the Taxes on law process licenses and all other public moneys which may come into his hands during his continuance in office on all citations proclamations and other instruments of publication under his Seal of Office then the above obligation to be void otherwise to remain in full force and virtue
