

This Indenture made and entered into this eight day of January in the
year one thousand eight hundred and thirty six between James Mordaugh of the County
of Southampton of the first part and Lewis C. Trezvant of the said County of the second
part witnesseth that the said Lewis C. Trezvant for and in consideration of the sum of three
hundred dollars to him in hand paid or received to be paid by the said Mordaugh,
the receipt whereof is hereby acknowledged, hath granted bargained, sold aliened, released and
conveyed out and by these presents with grant bargain, sell alien, release and conveyance
to the said James Mordaugh all right, title, interest claim and demand which he the said
Lewis C. Trezvant hath or had to all and singular the goods wares of merchandise of all and
every kind of denomination whatever which are in upon or in any way belonging or appertaining
to a Store in the Town of Jerusalem & County of Southampton and which said Store has
been and now is conducted and trading under the firm and style of Mordaugh & Trezvant
as well also as all the debts due and owing to the said firm: to have and to hold
to the said James Mordaugh his heirs & assigns forever. And it is further covenanted
and agreed between the said James Mordaugh and the said Lewis C. Trezvant, and
they are for the consideration that the said Lewis C. Trezvant has for the sum of
three hundred dollars as aforesaid released and conveyed to the present the stock in trade
belonging to the Store aforesaid conducted under the firm of Mordaugh & Trezvant in the
Town of Jerusalem as well also as all debts due to or in any wise belonging or apper-
taining to said firm, Now this Indenture witnesseth that for and in consideration of the
aforesaid premises the said James Mordaugh hath and doth by these presents acquit release
and forever discharge the said Lewis C. Trezvant from all liability or accountability for the pay-
ment of which the said firm of James Mordaugh and Lewis C. Trezvant are responsible
or may hereafter become responsible: in witness whereof the parties hereby bind themselves,
that their executors and administrators jointly & severally, firmly by these presents, each
to the other in the penalty of Three thousand dollars, faithfully to keep and observe the
covenants and covenants hereinbefore expressed on their parts respectively. In Witness where-
