

This Indenture made this sixth day of January one thousand eight hundred and thirty four between Wilson Jones and Margaret his wife of Isle of Wight County of one part and Josiah M. Delb of Southampton County of the other part: Witnesseth that the said Wilson Jones and Margaret his wife for and in consideration of the sum of three hundred and fifty seven dollars to them in hand paid or otherwise received by the said Josiah M. Delb before the sealing, and delivering these presents the receipt whereof is hereby acknowledged, hath given to the said Josiah M. Delb and to his heirs and assigns forever all our interest in and to the same tract or parcel of Land containing by estimation three hundred and fifty seven acres, including the track called Norrons and bounded on the east by the main Run of Blacks River Swamp, on the north by the Lane of Nathaniel Greenhaw, Henry M. Millman and John Millman, on the west and South West by Tarpin Swamp, and South by Proctors Road and Proctors Bridge, together with all trees, woods, underwoods, bolls, commodities, advantages, appurtenances and appurtenances whatsoever to the said Land belonging or in any wise appertaining and also the reversion, remainder and remainders rights and services of the said premises and every part thereof and all the estate right, title, interest claim or demand whatsoever of them the said Wilson Jones and Margaret his wife or their heirs &c of, in or to the said premises or any part thereof to have and to hold all and singular the premises above mentioned and every part and parcel thereof with the appurtenances unto the said Josiah M. Delb his heirs and assigns to the only proper use and behoof of him the said Josiah M. Delb ^{and assigns forever} and the said Wilson Jones and Margaret his wife their heirs &c the premises above mentioned and every part thereof unto the said Josiah M. Delb his heirs and assigns shall and will warrant and forever defend the right of the Land above mentioned against them and their heirs and every other person or persons claiming by these presents.
