To have and to hold the aforesaid three tracts or parcels of land and premises with all and singular their appurtenances thereto belonging unto him the said Josiah Norrell his heirs and assigns forever. (To and for the only proper use and behoof of him the said Josiah Norrell his heirs and assigns forever) and the said Lewis Norrell and Temperance Norrell his Wife for themselves their heirs executors, administrators, and assigns, them doth hereby covenant and agree to and with the said Josiah Norrell his heirs executors, administrators, and assigns, that they will by their presents present and forever defend the right and title of the aforesaid three tracts or parcels of land and premises and every part or parcel thereof, against the claims or demands of all and every person or persons whatsoever. In Witness whereof the said Lewis Norrell and Temperance Norrell his Wife have hereunto set their hands and affixed their seals this day and year first above written.
