This Indenture made this 15th day of Dec. in the year of our Lord Christ one thousand eight hundred and thirty five between Samuel Turner and Elizabeth Turner his wife of the County of Southampton and State of Virginia & Parish of Nottingham of the one part and Eli Joiner of the same County State & Parish of the other Part, Witness that the said Samuel Turner and Elizabeth Turner his Wife for and in consideration of the sum of Fourteen dollars and ninety seven cents current money of Virginia to them in hand paid by the Eli Joiner, the receipt whereof the said Samuel Turner & Elizabeth his wife doth acknowledge themselves fully and amply satisfied and saids hath granted her grantees with aliened, possessed and confirmed and by these presents with grant bargain and sell unto the Eli Joiner, to him and to his heirs forever one certain tract or parcel of Land containing Seven acres & 38 Poles be the same more or less and bounded as follows (to wit) Beginning at a Red oak corner of Samuel Turner's land thence N 80° E. 10 chains to a Red oak corner between the said Eli Joiner and Samuel Turner, Thence N 5° E. 33 chains 7 links to a pine on the said land, thence N 9° E. 2 chains & 33 links to a Spring a corner of Eli Joiner and Jeremiah Joiner, thence S 88° W 7 chains to a black gum thence S 78° W to a red oak corner between the said Samuel Turner and Eli Joiner, thence a straight line to the first station. To have and to hold the same unto the said Eli Joiner, to him and to his heirs forever. And the said Samuel Turner and Elizabeth his wife for themselves, their heirs, Exors. admors. or assigns doth by these presents covenant and grant to and unto the said Eli Joiner his heirs Exors. admors. or assigns that they will by these presents warrant and forever defend all right title claim or demand of any person or persons claiming, or demanding, the same or any part or parcel thereof. In Witness whereof the said Samuel Turner and Elizabeth his wife hath therunto set their hands and affixed their seals this day and date within written.
