Witnesseth that for and in consideration of the sum of three thousand five hundred dollars, the receipt whereof is fully acknowledged by the sa. John Drewry hath granted, bargained and sold and by these presents do grant bargain & sell unto the sa. James Drewry his heirs & assigns forever one certain tract or parcel of land lying and being in the aforesaid County and bounded as follows on the east by the lands of Calvin B. Blair, James Myrick and the lands lately purchased by the said James Drewry of John Ship- ert, on the North by the lands of Starling Elders on the West by the lands of Frances (un- ert, formerly Harris' land on the South by the Meherrin River containing six hundred acres, it to be the same, more or less, and to appear more fully, it is the same tract or parcel of land sold by the said James Drewry to the said John Drewry some time in the year Eighteen hun- dred and thirty-five together with all the improvements and benefits thereunto belonging, to have and to hold unto the said James Drewry his heirs & assigns forever, which said lands of the said John Drewry, do warrant and forever defend the right and title unto the sa. James Drewry his heirs and assigns forever against the claims or claims of any person or persons whatsoever. Witnesseth that the said Wil- liam Prince Jr. and Martha A. his Wife hath for and in consideration of the sum of Two hun- dred and six dollars to them in hand paid by the said John Prince, the receipt whereof the said William Prince Jr. and Martha his Wife both hereby acknowledge and confess, hath given granted, bargained and sold and by these presents do grant bargain sell & confirm unto the said John Prince, one certain tract or parcel of land, lying, being, and situate in the County of Southampton, containing Eighty eight and one third acres, or the same more or less and bounded by the lands of James C. Feltus, John Prince of the Estate of Edward Rice decd. To have and to hold, possess and enjoy the said tract or parcel of land and premises, with the appur- tenances unto the said John Prince his heirs and assigns to the only proper use and behoof of him the said John Prince his heirs and assigns forever. And the said William Prince Jr. and Martha A. his Wife, for themselves and their heirs the aforesaid tract or parcel of land and premises to the said John Prince his heirs and assigns against themselves and their heirs and against all and every person or persons whatsoever shall and well warrant and by these presents
