Lewis & Jesse Parker, Justices of the peace in the County of Southampton in the State of Virginia, do hereby certify that Vienna Joyner the Wife of William Joyner parties to a certain Deed bearing date on the day of 1836 and heretofore entered personally appeared before us, in our County aforesaid, and being examined by us privately and apart from her husband and having the said aforesaid fully explained to her she the said Vienna Joyner acknowledged the same to be her act and deed and declared that she had willingly signed sealed and delivered the same and that she wished not to retract it. Given under our hands and seals this 18. day of April 1836.

This Indenture made and entered into on the 13th day of April in the year of our Lord a thousand eight hundred and thirty-six between Syzana Ferguson of the County of Southampton & State of Virginia of the one part and Jacob Jordan of the same County and State of the other part. It is hereby that the said Syzana Ferguson for and in consideration of the sum of twenty-two dollars & fifty cents current money of the Commonwealth to her in hand paid by the said Jacob Jordan at or before the making and delivery of these presents, the receipt acknowledged, both parties being sane, sober, advised, informed and confirmed and by these presents with grant bargain, sell, alien and confirm unto him the said Jacob Jordan his heirs and assigns forever an certain tract or parcel of Land (situate) lying and being in the aforesaid County of Southampton and parish of Saint Luke's containing by estimation three acres (be the same more or less) at being the same of which Ann Pope Mother of said Syzana Ferguson did possess, and bounded by the heirs of said Jacob Jordan and John Hargrove. To have and to hold the above described tract or parcel of land and premises, with its appurtenances thereto belonging or in any wise appertaining unto him the said Jacob Jordan his heirs and assigns forever (to and for the only proper use and behoof of him the said Jacob Jordan his heirs and assigns forever). And the said Syzana Ferguson for herself, her heirs Executors and assigns with heretofore covenant and agree to and with the said Jacob Jordan his heirs Executors, Admins and assigns that she will by these presents make and forever assure the right and title of the aforesaid tract or parcel of Land and premises and every part or parcel thereof, against the claims or demands of all and every other person or persons (Whosoever) In witness whereof the said Syzana Ferguson hath hereunto set her hand and seal the day and year first above written.
