Know all men by these presents, that I Jesse Norrell of the County of Southampton in the State of Virginia for and in consideration of the natural love and affection which I bear to Mildred Johnson of said County and State as well as for the further consideration of the personal services of the said Mildred Johnson to me rendered for the last pasted two or three years, the Right of which services is hereby acknowledged have given and granted and by these presents do give and grant unto the said Mildred Johnson her Executors, administrators and assigns the following named articles of property to wit four feather beds and furniture, one chest, one Tall oak Bedsteads one Bedstead, one Toy box, 1st of knives and forks, six Spoons, one Rush seat Chair, two horses, 20 head of sheep, two head of Cattle, my personal growing crop of corn, fodder and feed; to have and to hold the above named articles of property unto her the said Mildred Johnson her Executors, administrators and assigns forever. Nevertheless I the said Jesse Norrell retain to myself my Executors & administrators the above named articles of property and the said Mildred Johnson her Executors administrators and assigns against the Claim of him the said Jesse Norrell his Executors and assigns and against the Claim or claims of all and every person or persons whatsoever shall and will warrant and forever defend them by these presents.
