This Indenture made and entered into on the 18th day of November in the year of our Lord Eighteen hundred and Thirty six between Henry B. Naughan of the County of Southampton and State of Virginia of the one part, and John Thorp of the same County and State of the other part: Witnesseth that the said Henry B. Naughan for and in consideration of the sum of one thousand and thirteen dollars, lawful money of Virginia to him in hand paid by the said John Thorp at or before the executing and delivery of these presents, the receipt whereof is hereby acknowledged, hath granted, bargained, sold, aliened, conveyed, confirmed and by these presents doth grant bargain sell, alien, convey and confirm unto him, the said John Thorp his heirs and assigns forever one certain tract or parcel of Land (situated) lying and being in the aforesaid County of Southampton and Spanish of Saint Lukes containing by a late Survey Two hundred and fifty three & one fourth acres (be the same more or less) and bounded as follows (to wit) beginning at a black gum standing in the run of Thomas' Swamp a corner for said John Thorp and Abner Stephenson thence along said John Thorps line N. 31° E 21 poles to a white oak thence N. 48 1/2° E 48 poles to a large post oak, thence N. 47° E. 34 poles to a pine, thence N. 44° E. 44 poles to a red oak thence N. 45 1/2° E 38 poles to the center of the Millfield Road, thence along the said Road S. 80° E 12 poles thence S 73° E 18 poles thence S. 80° E 28 poles to a corner for Williams Ridley, thence a new line between said Henry B. Naughan and John Thorp S 11 1/4° N. 240 poles to a post thence S. 48° N 8 poles to a red oak, thence S 41° 1/2° N 14 poles to a maple thence S. 43° N. 4 poles to a pine thence S. 47° N 12 poles to a Hickory, thence S 44 1/2° N 20 poles to a pine, thence S 43° N 11 poles to a black gum standing near the run of the aforesaid Thomas Swamp thence up the run of said Swamp to the first Station - Together with with all right, title interest claim or demand of in and to the above described tract or parcel of Land and premises, with its appurtenances thereto belonging or in any wise appertaining. To have and to hold the aforesaid tract or parcel of of Land and premises, with all and singular its appurtenances thereto belonging, unto him the said John Thorp his heirs and assigns forever (to and for the only proper use and behoof of him the said John Thorp his heirs and assigns forever). And the said Henry B. Naughan for himself, his heirs executors and assigns doth hereby covenant and agree, to and with the said John Thorp his heirs Executors, admin. and assigns that he will by these presents warrant and forever defend the right and title of the aforesaid tract or parcel of Land and premises and every part or parcel thereof against the claims or demands of all and every other person or persons. Buttland of the other part - all of the County of Southampton and State of Virginia - Witnesseth that the said Joseph Senow and Frances Senow for an in consideration of the sum of six hundred and fifty dollars, unto to them in hand paid by the said Jeremiah C. Buttland, the receipt whereof the said Joe Senow and Frances Senow doth hereby acknowledge themselves fully satisfied and paid, and of the same doth by these presents acquit the said Jeremiah C. Buttland, they the said Joe Senow and Frances Senow doth hereby granted, bargained, and sold aliened conveyed confirmed and by these presents do grant bargain and sell, alien, convey and confirm unto the said Jeremiah C. Buttland all and a certain tract or parcel of Land containing by estimation one hundred acres, be the same more or less lying and being in the County aforesaid and bounded as follows - beginning at Round Hill bridge, thence the various courses across the said Round Hill Swamp to Richard Stephenson's
