

End of deed to John Wilson 1st Apr 1837

ing in the aforesaid County of Southampton and Parish of Nitloway, containing by a recent Survey one hundred acres (or be that same more or less) and bounded as follows (to wit) beginning at a black gum standing in a large branch, a corner for the lands of Crown Ricks side, also a new corner for said Thomas N. Story, thence along said Thomas N. Story's line N. 32 1/2° E 35 poles to a small black gum thence N 33 1/2° E 138 poles to the road, thence along said Road S 26° E 17 poles thence S 37° E 38 poles thence S 18° E 31 poles to the fork of the Roads, thence S. 14° W 18 poles to the aforesaid large branch, Arnold Ricks side corner, thence the various courses of the run of said branch to the first station: Together with all right, title, interest, claim or demand of or in and to the above described tract or parcel of Land and premises, with its appurtenances thereto belonging or in any wise appertaining. To have and to hold the aforesaid tract or parcel of land and premises, with all and singular its appurtenances unto him the said John Wilson his heirs and assigns forever (to and for the only proper use and behoof of him the said John Wilson his heirs and assigns forever). And the said Thomas N. Story and Catharine his Wife, for themselves, their heirs Executors or administrators, as and each of them doth hereby covenant and agree to and with the said John Wilson his heirs Executors administrators and assigns that they will by these presents Marrant and forever defend all the right, title, interest, claim or demand of or in and to the aforesaid tract or parcel of land and premises and every part or parcel thereof, against the claims or demands of all and every other person or persons whatsoever. This Indenture made the 19th day of October in the year one thousand eight hundred Commissioners and thirty-six between Patrick Rows and Rowan's Griffin Commissioners appointed by the County Court for that purpose of the one part and William Harris of the other part. Witness that the said Patrick Rows and Rowan's Griffin Commissioners in consideration of the sum of sixty five dollars lawful money of this Commonwealth, to them in hand paid by the said William Harris at a before the making and delivery of these presents (the receipt whereof is hereby acknowledged) have sold and their Executors do, and each of them doth sell unto the said William Harris his heirs and assigns a certain tract or parcel of Land containing twenty five acres or be the same more or less and bounded as follows it being the place where Mills Turner formerly lived and side, bounded by the south by the Lands of Patsy Turner, by the east by Lands of the aforesaid William Harris, and by the North by the said William Harris, and by the West of the Lands of Matthew Wells together with all (the singular, houses, some houses, barns, buildings, Stables, yards, gardens, orchards, Lanes,
