under the seal of the Commonwealth dated the 29th day of November 1836. If therefore the said Ben-
jamin Griffin shall well and truly collect and receive all officers fees and dues put into his hands to collect
and duly account for and pay the same to the officers to whom such fees are due respectively, at such time
as are prescribed and limited by Law, and shall well and truly execute and due return make of all pro-
cess and precepts to him directed and pay and satisfy all sums of money and damages by them received
by virtue of any such process, to the person or persons to whom the same are due, his or their Executors
Administrators or assigns and in all other things shall truly and faithfully execute and perform the said
office of Sheriff during the time of his continuance therin, then the above obligation to be void, otherwise
to remain in full force and virtue.
