This Indenture, with the certificate annexed, was returned and admitted to record, and at a Court held for the County aforesaid the 20th day of February 1837. The said Indenture was entered upon the proceedings of the day.

This Indenture made this day of November in the year 1836 between Martha B. Rockelle of the one part and Littleton R. Edwards of the other part, both of the County of Southampton whereas James Rockelle, late of this County deceased, did by his last Will and Testament, among other things direct that the tract of Land that he purchased of William J. Scott, called Bucks, containing 519 acres be sold by his executors on such terms and at such time as she might think desirable, and that she execute legal acts of conveyance for the same and apply the proceeds of such sale to the payment of his debts, and he the said James Rockelle, did, by his said last will and testament constitute and appoint the said Martha B. Rockelle Executrix thereof. And whereas the said Will was proved and admitted to record in the court of Southampton County on the 21st day of September 1835 and on the same day the said Martha B. Rockelle the executrix qualified as such by performing what was necessary for settling a probate of the said Will. And Whereas the said Martha B. Rockelle Executrix as aforesaid by virtue of the power vested in her by the said Will set on the 21st day of November 1836 having given reasonable public notice thereof, set up and sold publicly to the highest bidder upon a writ of twelve months the tract of Land above mentioned containing five hundred and nineteen acres, and the said Littleton R. Edwards became the purchaser thereof at the price of one dollar and thirty cents per acre, that being the highest bid made for the same. This indenture therefore witnesseth that the said Martha B. Rockelle Executrix of the last Will and Testament of James Rockelle aforesaid, for and in consideration of the sum of six hundred and seventy four dollars and seventy cents to her secured to be paid, and also in consideration of one dollar to her in hand paid by the said Littleton R. Edwards before the sealing and delivery of these presents, have granted, bargained and sold and by these presents do grant,
