And that the proceeds of such sale after paying and satisfying all cost attending the execution of this trust be applied by the said Bowman M Bryant to the discharge of the aforesaid of four hundred and ten dollars & 25 c. due and owing to the said Davis Bryant as aforesaid or so much thereof as may then be due together with the interest which shall have accrued thereon. And any surplus of money (hereafter remaining) in the hands of the said Bowman M Bryant is to be paid over to the said Anthony Brown his heirs, executors administrators or assigns. In case any part of the said Land or other property shall remain unsold after paying the said sum of money and interest then the said Bowman M Bryant is to release to the said Anthony Brown all the title herein transferred to him and in case the said Bowman M Bryant shall die before the execution of this trust his executors or administrators are to carry this indenture into effect and operation. And the said Anthony Brown for himself his executors and administrators hereby warrants to and with the said Bowman M Bryant his heirs executors administrators and assigns that the aforesaid tract or parcel of Land and other property is free and clear from the claim or claims of any person or persons whatsoever, shall and will warrant and forever defend by these presents the right and title of the said tract of Land unto him the said Bowman M Bryant his heirs executors administrators or assigns. This Indenture, made the twenty second day of November in the year of our Lord one thousand eight hundred and thirty six, between Thomas J Hart of the County of Southampton & State of Virginia, of the first part & Myatt Hancock of Surry County and aforesaid State of the second part & his heirs of the aforesaid County of Surry & State of the other part. Witnesseth that the said Thomas J Hart in order to provide for and secure the payment of a debt of Three hundred dollars with interest thereon etc paid, lawfull money of Virginia due to the said Hawkins Jones by note under seal bearing date the first day of May eighteen hundred & thirty six. And for & in consideration of the sum of one dollar in hand paid to the said Thomas J Hart by the said Myatt Hancock at or before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged hath granted bargained and sold and by these presents took bargain & sold, alene, in fee simple and confirmed unto the said Myatt Hancock his heirs, executors or assigns the following property to wit one whole piece or parcel of Land lying and being in the County of Southampton & State aforesaid containing fifty acres, and the lands where the said Thomas J Hart now lives on. And further that tract where the improvements are on, and adjoins the lands of the said Hawkins Jones & Jno Hart, also one cow and calf, one sow and nine pigs, five hogs, five barrels of sound corn, Two feather beds & furniture, Three pine chest, half dozen maple setting chairs three iron pots, two pair pot hooks, one Spider, one spit rack, one pair of songs & one shovell, Two pine tables, one soft eighteen earthen plates, two earthen dishes one dozen soups of a dozen saucers, half dozen knives & forks one iron; one six hundred slay, one pair iron wedges, two marrow bones of one half bushel, one brace plow, three plow hoes of one collar, one pair of traces swinge trees & blenies, and all the estate, right and title thereto in the said Myatt Hancock his heirs and assigns forever, to have and to hold the said property all and every species thereof unto him the said Myatt Hancock his executors or assigns forever.
