This Indenture made this 10th day of March in the year of our Lord eighteen hundred and Thirti seven between Jacob H. Duck of the County of Isle of Wight of the one part, Henry Jones in the County of the second part and Polly Griffon of the said County of Isle of Wight of the third part: Whereas the said Henry Jones on the 21st day of November in the year of our Lord eighteen hundred and Thirti six, in order to secure the payment of the sum of Ninety dollars to the said Polly Griffon, did by indenture of trust of that date convey to the said Jacob H. Duck his heirs executors &c the following tract, piece or parcel of Land containing Thirti seven and half acres be the same, more or less, lying and being in the County of Southampton and bounded by the lands of Samuel Corbet Junr. William English, Joel Councill & Hardy Lawrence, upon trust for the uses and purposes in the said Indenture mentioned: And whereas since the making and delivering of the said act of trust the said Henry Jones hath fully satisfied and paid off to the said Polly Griffon the sum of money thereby secured which the said Polly Griffon doth hereby acknowledge. Now this Indenture witnesseth that for the consideration aforesaid, as well as for the further consideration of one dollar in hand paid by the said Henry Jones to the said Jacob H. Duck at and before the executing and delivery of these presents, the receipt whereof is hereby acknowledged, to the said Jacob H. Duck with the agent and apportionment of the said Polly Griffon signified by her being part to these presents and the said Griffon have granted bargained and sold, remised, released and confirmed and by these presents
