This Indenture made and entered into this 18th day of March in the year 1837 between Henry Westbrook
 of the first part Henry Kincaid of the second part and William Morrell of the third part all of the County of South-
 ampton and State of Virginia, Witnesseth, whereas the aforesaid Henry Westbrook hath become justly indebted in a certain
 obligation, bearing equal date with these presents of the sum of seventy dollars 96 cents, in ut, whereas the said Henry
 Westbrook is willing and desirous of securing the said Henry Kincaid in the above sum of seventy dollars and 96
 cents. Now this Indenture further witnesseth that the said Henry Westbrook hath for and in consideration of the
 sum of one dollar to him hereof paid by the said William Morrell the receipt is hereby acknowledged, hath granted,
 bargained and sold and by these presents does grant bargain & sell unto the said William Morrell his heirs and af-
 signs forever the following property, to wit, one small Horse two beds & furniture one large chest one buffet, three
 trunks one gun one set of knives and fork, specie of Ceanothus three one spinning wheel two pair shears one pair,
 three sples one soon two shillies, two tables parcel of Books, two long, a parcel of Salt & spates. To have and
 to hold the aforesaid property to him the aforesaid William Morrell his heirs or assigns to the only proper use and
 behoof of him the said William Morrell his heirs or assigns forever. Upon this special trust and confidence
 notwithstanding to and for the use intents and purposes following, Wist the said William Morrell at any time here-
 after whenever he shall be requested by the said Henry Kincaid his heirs or assigns make sale of the aforesaid
 property at public auction to pay unto satisfy the aforesaid claim of seventy dollars and 96 cents with interest &
 cost that may accrue thereon by advertising the day and place of such sales at least three publick places as the
 said William Morrell may think proper as to render complete justice to the parties at least ten day previous
 notice to the day of sale for ready and lawfull money of Virginia and out of the proceeds of such sales pay
 unto the aforesaid Henry Kincaid his heirs or assigns the full amount of the above claim together with in-
 terest thereon and costs carrying into effect of these presents and the overplus if any shall pay unto the said
 Henry Westbrook his heirs or assigns. In Witness whereof we have hereunto set our hands and affix'd our seals
