This Indenture made and executed this twenty eighth day of February in the year of our Lord one thousand eight hundred and thirty seven, between J. C. Cottland and Elizer his Wife of the one part and Francis Senow of the other part, all of the County of Southampton and State of Virginia. Witnesseth that the said J. C. Cottland and Elizer his wife for and in consideration of the sum of Six hundred and fifty dollars to them in hand paid by the said Francis Senow, the receipt whereof the said J. C. Cottland & Elizer his Wife, doth hereby acknowledge themselves fully satisfied and paid, and of the same oath by their presents acquit, the said Francis Senow, they the said J. C. Cottland & Elizer, his wife, hath granted bargain and sold aliened infeoffed and confirmed and by these presents do grant, bargain and sell, alien, exempt and confirm unto the said Francis Senow a certain tract or parcel of land containing by estimation one hundred acres, be the same, more or less, and being in the County aforesaid and bounded as follows beginning at the Round Hill bridge thence the various courses down the said Round Hill Swamp to the line of Rich and Stephenson and thence up the branch along in Stephenson's line to a corner gum, thence a course of marked trees to a corner red oak, immediate on the east side of the main road leading from Jerusalem to Smithfield thence down said Road to a corner pine between said Senow and Mister J. B. Bortles and thence a line of marked trees a north West course to a corner with Samuella M. Bond and thence a south course running across the Hunting and from said Road a line of marked trees between said Senow and Robert C. C. um and to a corner pine between the said C. um & Senow, and from thence a line of marked trees to the Smithfield Road and thence up said Road to the beginning at Round Hill bridge it being the same tract of land of Senow which I purchased of Joseph Senow & Francis Senow, which is of record in the County aforesaid and said land is known by the names of Round Hill or Store Road - with the appurtenances thereto belonging or in any wise appertaining, with the reversion and reversions, remainder and remainders rent of issue and profits thereof and every part and parcel thereof To have and to hold the said bargain and promises with the appurtenances unto the said Francis Senow his heirs and assigns forever; and the said J. C. Cottland & Elizer, his wife for themselves, their heirs executors and assigns the said bargain and promises and every part and parcel thereof with all their appurtenances clear, exempt and secure from all claims or other incumbrances whatsoever unto the said Francis Senow his heirs and assigns against all and every person or persons whatsoever, decd. shall and will by these presents forever warrant and defend.
