This Indenture made and entered into this 8th day of May in the year of our Lord  
eighteen hundred and twenty two between Thomas Turner of the first part Merit M. Cley of the second  
and John Wogahart of the third part all of the County of Southampton and State of Virginia. Testifyeth that  
the said Thomas Turner for and in consideration of the sum of Eighty dollars of lawful money, which he justly  
owes to the said John Wogahart by note bearing date the eighth day of May 1822, as also for and in consid-  
eration of the sum of one dollar to him in hand paid by the said Merit M. Cley, the receipt whereof the said  
Thomas Turner doth hereby acknowledge, he the said Thomas Turner doth bargain sell convey and make over  
and by these presents hath granted bargained sold conveyed and made over unto the sd Merit M. Cley his heirs  
and assigns forever one certain tract or parcel of Land, being the same I now reside on, containing by estima-  
tion forty four acres, be the same more or less and bounded by the Lands of Mills Cley and Benjamin  
Crompler. To have and to hold with all the right title and interest, of him the said Thomas Turner here-  
in conveyed or intended to be conveyed unto him the said Merit M. Cley his heirs and assigns forever upon  
this Special Trust - Nevertheless, that the said Merit M. Cley being thereto required, by the aforesaid John  
Wogahart, at any time, shall proceed to sell the aforesaid tract or parcel of Land herein conveyed or intended  
to be conveyed, (after advertising the time and place at some public house or store in Southampton County  
for ten days previous, for cash and out of the money arising out of from the said sales in the first place  
pay and satisfy all cost attending the said sales as well as the expenses attending this conveyance and then  
pay off the bond aforesaid with interest and the surplus if any, pay to the said Thomas Turner, and the  
said Thomas Turner, for himself his heirs, executors, administrators, and assigns, the rights and titles of the said Land,  
unto the said M. M. Cley his heirs and assigns forever doth hereby warrant and will forever defend against the  
lawful claim or claims, of him the said Thomas Turner his heirs, executors, administrators, and assigns, the lawful claim  
of all and every person and persons whomsoever. And the said Merit M. Cley on his part covenants and agrees  
that he will make sale of the said tract or parcel of Land hereby conveyed or intended to be conveyed for the best  
price he can obtain for the same, after advertising the time and place for ten days previous, at some public  
house or store, of the County of Southampton and with the money arising out of from the said sales in the  
first place, pay and satisfy all cost attending the sale as well as the expenses attending this conveyance,  
and then pay off the aforesaid bond with interest and the surplus, if any, pay to the said Thomas Turner,  
and the said John Wogahart on his part, covenants and agrees that he will release the said Thomas Turner from  
the obligation of this indenture, at any time previous to a sale of the said Land, upon the said Tho-  
mas Turner discharging the aforesaid bond with the interest, that may accrue thereon and the expenses of this
