This Indenture, made and entered into this 14th day of August 1837, between Jonathan Bryant, Martha Bryant & Wife & Bryant his Wife and Selley Bryant his Mother of the first part and Levi Powers all of Southampton County Virginia of the second part, Witnesseth that the said Jonathan Bryant, Martha, his Wife & Selley his Mother for and in consideration of the sum of Ten dollars to them in hand paid by the said Levi Powers the receipt whereof is hereby acknowledged, hath granted bargained and sold and by these presents doth grant bargain & sell unto the said Levi Powers his heirs and assigns forever, a certain tract or parcel of Land in the said County lying on the New Road to Franklin (East side) being part of the do tract owned by the late Jonathan Bryant decd. containing by estimation Two acres to the same more or less and bounded as follows, to wit, beginning at a small white oak standing in a branch a corner in John Bells line thence up the branch a few spaces to the above mentioned New Road, thence along said Road a North course, to where Jonathan Bryants line crosses the said Road, thence an east course along said Jonathan Bryants line to an oak a corner tree, thence a south course along a line of marked trees (binding) on Levi Powers land to the white oak, the first station. Together with the reversions or reversions, remainder or remainders, heirs and their heirs & assigns thereof and every part and parcel thereof. To have and to hold, the said tract of Land with all the appurtenances and every part and parcel thereof, unto the said Levi Powers and his heirs for ever. And the said Jonathan Bryant, Martha, his Wife and Selley his Mother for themselves and their heirs the said tract of land, unto the said Levi Powers his heirs and assigns free, from the claim of all persons whatsoever, shall will and do for ever defend by these presents.
