This Indenture made and entered into this 8. day of November 1837 between Mary Williams (inward) of the first part and Theodore Tregwant of the second part all of the County of Southampton. Witnesseth that the said Mary Williams for and in consideration of the sum of Two hundred & Twenty nine dollars & fifty cents to her in hand paid, the receipt whereof is hereby acknowledged, have granted bargained & sold and by this present as grant bargain & sell unto the said Theodore Tregwant and his heirs and assigns forever, a certain tract or parcel of Land, lying in the County aforesaid. It being a portion of the Notaway, Tribe of Indians, so called containing by estimation fifty one acre being the Lot No 5 as will more fully appear by reference to the Plat of said Lands allowed to me in fee simple by the Justice of the aforesaid tribe of Indians. bounded on the south by the lands of Lewis Merrill with the reservation & reservations remainder & remainders rents and profits thereof. To have and to hold, to the said Theodore Tregwant his heirs and assigns forever and the said Mary Williams for herself her heirs and assigns, hereby warrant and defend the title of the aforesaid Tract of fifty one acre of Land to the said Theodore Tregwant his heirs & assigns forever. In Testimony whereof the said Mary Williams (Indians) have hereunto set her mark & affixed her seal this day and year forth above written.

Corbett doth warrant and agree with the said Edwin Mallet his heirs and assigns, with warrant and force to feed the aforesaid Land and premises unto him the said Edwin Mallet his heirs and assigns forever against the lawful claim or claims of any person or persons whatsoever.
