This Indenture made this 26th day of April 1836 hundred and thirty seven. Between R. Blount of this
County of Baldwin and State of Virginia of the one part, and John D. Turner of the County of Southampton one State of
North Carolina of the other part; witnesseth that the said R. Blount for and in consideration of the sum of six hundred
dollars, the receipt whereof is hereby acknowledged has bargained sold, conveyed and confirmed and by these presents does
bargain sell convey and confirm unto the said John D. Turner his heirs and assigns a certain tract or parcel of Land
situated lying and being in the County of Southampton in the State of Virginia, Beginning at a bowl wood just in
the big Swash near Smith's sea causway, thence down the middle of said Swash to a bypath at corner in Smith
of Jones's land, thence Eastwardly along Jones's line to a gum corner in the Swamp, thence up the middle of said
Swamp, and at Branch to an oak corner, thence to a fence corner at Jones's fence, thence northwardly at straight line
to an oak corner on Nathan Poppe's line, thence westwardly to John Whitehead's line, thence down the meadow and
and a branch to a line, at first line to a gum at the beginning containing two hundred acres, more or less, to
him and to hold the said bargained land and premises with all their appurtenances of every kind whatsoever
unto the said John D. Turner his heirs and assigns forever. And the said R. Blount for himself, his heirs and
assigns does hereby covenant and agree to warrant and defend the right and title to the said bargained land, unto the
said John D. Turner his heirs and assigns against the claim or claims of all and every person or persons that claim
