Witnesseth That the said William D Hodges in consideration of the sum of eight hundred dollars to him in hand paid by the said William D Bryant at or before the sealing and delivery of these presents of these presents (the receipt whereof is hereby acknowledged) hath, let and conveyed and by these presents doth sell and convey, unto the said William D Bryant, his heirs and assigns, the before mentioned tract or parcels of land lying and situated in the County of Southampton and near the body of Hopyard, the one being commonly known by the name and designation of the "Pine Hill Tract" and containing by estimation one hundred and eighty three acres and the other by the name and designation of the "Annis James tract" and containing by estimation ten acres, together with all the rights and appurtenances thereto belonging. He have and to hold the said tract or parcels of land with their rights and appurtenances as aforesaid unto the said William D Bryant his heirs and assigns forever. And the said William D Hodges as Commissioner as aforesaid, for himself and his heirs, the said tract or parcel of land, with their rights and appurtenances as aforesaid, unto the said William D Bryant, his heirs and assigns, free from the claim or claims of him the said William D Hodges and all those who may claim under or through him the said William D Hodges, and no further with warrant and record. This Indenture, made this 18th Decr 1837 between Thomas B. Beale of the one part and William D Hodges, form of the County Court of Southampton to sell the slaves herinafter named of the other part. Witnesseth That the said Thomas B. Beale with his wife conveys to the said Wm D Hodges the slaves George & John the days purchased of the said William D Hodges (formerly belonging to the estate of Richard Hodges) and sold for division among the heirs, in trust that in case the said Thomas B. Beale shall not pay the sum of twelve hundred and seventy three dollars at the expiration of six months from the present date the said slaves shall be reconveyed to him; but in case he shall not it shall be competent for the said Wm D Hodges to sell the same in such manner as he shall think best calculated to discharge the said debt, and to apply thereto the proceeds of the sale, and the payment of the expenses of this trust and to pay whatever surplus may remain in his hands to the said Thomas B. Beale. In witness whereof the said Thomas B. Beale & William D Hodges have hereunto affixed their hands & seals this day of year aforesaid.
