And if the said Hodayay Revell senior, with covenant and agree to and with the said Children above mentioned to warrant and defend the just right and title of the above mentioned property now in possession of the above mentioned Hodayay Revell Junior against the lawful claim or demands of any Person or persons whatsoever. This Indenture made this 5th day of Dec. 1837 between Parsons Turner & Daniel H. Bromgolds both citizens of this County of Southampton, Minors, that the said Parsons Turner for and in consideration of the sum of Two hundred and twenty nine dollars 50/100 lawful money of Virginia to him in hand paid at or before the executing of these presents the receipt whereof is hereby acknowledged, hath bargained, granted and sold and by these presents, with good bargain and sell unto the said Daniel H. Bromgolds his heirs and assigns a certain tract or parcel of Land, part of the tract known as the Indian lands containing by survey fifty one acres, adjoining the lands of Lewis Howell which he purchased from Henry and Green Turner, lying between parallel lines running East and West on the eastern end by a line north & south on the eastern boundary by a line N 13° E. to have and to hold the said tract or parcel of Land with the appurtenances thereto belonging to him the said Daniel H. Bromgolds his heirs and assigns forever. In Witness whereof the said Parsons Turner hath hereunto set his hand and affixed his seal this 5th day of Dec. 1837.

This Indenture made this 15th day of January in the year one thousand eight hundred and thirty seven between James A. Schell of the County of Southampton of the one part and Joseph Drury of the said County of the other part Minors. That the said James A. Schell in consideration of one cent of lawful money of this Commonwealth to him in hand paid by the said Joseph Drury, at or before the executing of these presents, hath bargained and sold and by these presents do bargain and sell unto the said Joseph Drury his heirs and assigns, a certain tract or parcel of Land with the appurtenances, situate, lying and being in the County of Southampton, containing twenty nine acres, be the same more or less and bounded as follows to wit, beginning, a white oak a corner of the above tract and Susan Cobb and running S 15° E 61 poles, thence N 74° E 29 poles, thence S 15° E 61 poles to a white oak near a path, thence N 74° E 59.74 to the beginning, together with all and singular the appurtenances whatsoever to the said land belonging or appertaining or with the same used or enjoyed or lawfully reputed taken or known as part parcel or member thereof or as belonging to the same or any part thereof.
