This Indenture made this 20th day of March in the year of our Lord one thousand eight hun-
dred and thirty eight, between John R. Muller of the County of Southampton and state of Virginia of the one
part and Samuel Dewey of the said County and state of the other parts and Tho' Simmons Jory of the County
of Sussex and state of Virginia of the other parts Witnesseth that whereas the said John R. Muller stands
justly indebted to the said Tho' Simmons Jory by one written obligation bearing date the 17th day of February
1838 for the amount of five hundred dollars and whereas for the further assurance and security for the payment
of said debt it is agreed by the said John R. Muller and Tho' S. Jory that a conveyance in trust shall be made to
Samuel Dewey for the benefit of the said Tho' S. Jory in case the said claim shall not be spontaneously paid by
the 25th day of December next: now this Indenture witnesseth that the said John R. Muller for and in con-
sideration of the premises aforesaid and for the further consideration of one dollar to him in hand paid through
whereof is hereby acknowledged hath granted bargained and sold released and confirmed and by these presents
doth for himself his heirs or assigns grant bargain sell alien release and confirm and make over to the said
Dewey and to his heirs and assigns the following (property to wit a certain tract or parcel of land lying
and being in the County aforesaid and bounded as follows, to wit by the land of James C. Peters and Jory
Parker on the east by the land of John M. Tiller on the south by Mrs. B. Godwyn and west by John M. Tiller con-
taining three hundred and fifty one acres to be the same more or less also the following slave to wit a negro
twenty years with all and singular the appurtenances to the said tract or in any wise appurtening) and all the
estate right title and interest of the said John R. Muller in and to the said granted or intended to be granted
tract or parcel of land and premises. To have and to hold the said hereby granted or intended to be granted
tract or parcel of land and premises with its appurtenances together with the aforesaid slave. Intensely notwithstanding
and upon this express condition that if the said John R. Muller his heirs Executors assigns or assigns shall
voluntarily pay or cause to be paid by the said specified day the aforesaid claim of Five hundred dollars and the
legal interest which may accrue thereon then the said Samuel Dewey shall execute proper and legal re-
lease for the said property herein conveyed but it is agreed by the parties and declared to be the true intent and
meaning of the said parties to these presents and the said Samuel Dewey covenants and agrees with the said
Muller and Jory that in case the said Muller his Executors assigns or assigns shall fail to make payment of
the said debt & interest agreed to the tenor of the obligation then the said Samuel Dewey his Executors assigns
or assigns shall at the request of Tho' S. Jory or his heirs or assigns after the said 25th day of Decr next any
time after giving fifteen days notice sell at public auction the aforesaid property herein conveyed or so much
thereof as will be sufficient to satisfy the said debt before named with legal interest together with all expenses
attending the sale and touching this trust in any manner and shall pay the money arising from the sale
thereof to the said Tho' S. Jory his heirs or assigns or so much as may satisfy the said claim and cost &
after satisfying the said debt and cost the surplus if any to the said John Muller his heirs or assigns and
