This Indenture made this 24th day of August 1838 between Mills D Summer of the first part, William J Lebrell of the second part and Nicholas M Lebrell of the third part, and all of the County of Southampton. Whereas the said Mills D Summer is indebted to the said Nicholas M Lebrell in the sum of one hundred and fifty nine dollars due on a bond executed by the said Mills D Summer to said Nicholas M Lebrell of this date and payable on demand, which debt with the Interest that may accumulate thereon the said Mills D Summer is willing and anxious to secure. Now therefore the said Mills D Summer has bargained and sold and by these presents does bargain and sell unto the said William J Lebrell his executors and administrators and assigns the following property to wit: Two bars of iron, two tables, two trunks, chairs, kitchen furniture 2 horses, cow & calf, sow and pigs six sheats, but and wheels, farming utensils and crop of every description made by said Summer the present year. To have and to hold the said property to the said William J Lebrell his executors and administrators forever; Upon trust nevertheless that the said William J Lebrell is to permit the said Summer to retain possession of the said property until he shall be required by either the said Mills D Summer or the said Nicholas M Lebrell to sell, and then it shall be his duty (or in case of his death the duty of his executors or administrators) after having given at least ten days public notice of the time and place of sale, to sell to the highest bidder, for cash or on such other terms as may be agreed on by the parties the several articles of property herein mentioned or such part thereof as may be sufficient to satisfy the objects of this deed, and apply the money thus raised, first to the payment of the expenses of said sale and the drawing and recording this deed, and then to the payment of the debt and interest aforesaid and if any balance remain in his hands, he shall pay the same to said Mills D Summer or such other persons as may be authorized to receive the same, and the said William J Lebrell hereby covenants to perform the trust reposed in him. In and between Jonas Edwards of Southampton County, State of Virginia of the first part, Nancy Edwards of the second and Randolph R Gardner of the third part, witness that whereas the above named Jonas Edwards did on the 1st day of September 1838 execute a bond to Nancy Edwards for the sum of 282 dollars & 21 cents with interest from the date, with the above named Nancy Edwards and whereas the said Jonas Edwards is willing and desirous to indemnify the said Nancy Edwards from all and every expense whatsoever but more especially to secure the debt aforesaid and especially for and in consideration of one dollar and no more to him in hand paid by the said Randolph R Gardner at and before the making of
