hundred and thirty nine between Carr Bowers ^{admt.} D.B. of William B Bowers d.d. of the first part
Miles C Laurence of the second part, and William Laurence of the third part. Whereas the said Will
and Laurence on the twenty first day of January ^{in the year 1839} and ordered to receive the payment of the sum of
Two thousand nine hundred & eight dollars and forty seven cents to the said Miles C Laurence by
Indenture of trust of that date convey to the said Carr Bowers admt. D.B. of William B Bowers
his heirs and assigns the following property to wit: one tract of land beginning at black water bridge
Thence up said black water to the mouth of sea cock thence up the said run of sea cock to a line
running Smith line thence up a branch to a line of marked trees between the said claiming
Smith & said Simons to a large pine at the road thence round the said parcel to a marked tree
between John Luter and the said Daniel Simmons thence down the said branch to a line be-
tween John Luter and the said Daniel Simmons thence along a line of marked trees between John Luter and
and the said Daniel Simmons to the road at the corner of the said Luter pines thence
down the road to black water bridge the beginning containing eight hundred and thirty
Eight acres. Also beased. Sam Leriak & child Johnny Army & four children. Jameson Biers
Madison Torr and mill Station one Buck skin Also one hundred bands bars & one house hold
of kitchen furniture upon trust for the uses and purposes in said Indenture mentioned
whereas since the execution and delivery of said deed of trust to the said William Laurence both
fully satisfied and paid to the said Miles C Laurence the debt thereby secured which

or hold in the property above described. To have and to hold the said property as above described to
the said Wm. Laurence his heirs executors administrators and assigns forever. And the said Miles C
Laurence for himself and his heirs the abovesmentioned property unto the said William Laurence
his heirs and assigns in as full and ample manner as the same was warranted by the said Miles
C Laurence by the deed of trust above recited do warrant to come to the said William Laurence
