Ransom G Harrell at or before the executing and delivery of these presents (the receipt whereof is
hereby acknowledged) have bargained and sold and by these presents do bargain and sell unto
the said Ransom G Harrell his heirs and assigns a certain tract or parcel of land lying and being in
the County of Southampton and bounded in the following manner; to the North by pointed Road
to the West by the lands belonging to the said Ransom G Harrell on the South by Edwin
Millerford and to the East by the lands belonging to Robert Brerlow; it being the place of land
the said William Harrell drew from the Est. of his Father containing two hundred and forty
acres be the same more or less together with all the Lands Tenements profits emolumen-
ts hereditaments and appertaining whatsoever and the reversion and reversions remainder
or remainders yearly and other rents issues and profits there of and of every part and parcel
thereof. To have and to hold the said tract or parcel of land with the Tenements heredit-
aments and all and Singular other the premises herein before mentioned or intended to be
bargained and sold and every part and parcel thereof with every of their rights members
