This indenture made this 21st day of January in the year of our Lord 1839 between Albrigton
Bradshaw and Martha his wife of the County of Southampton and State of Virginia of the one part and
Rich^d H Branch of the same County and State of the other part Witnesseth: That the said Albrigton Brad-
shaw and Martha his wife in consideration of the sum of eight dollars and seventy five cents of lawful money
of this Commonwealth to them in hand paid by the said Rich^d H Branch at or before the making and
delivery of these presents the receipt whereof is hereby acknowledged have bargained and sold and by these
presents do and each of them doth bargain and sell unto the said Rich^d H Branch his heirs and assigns
a certain piece of Land containing few acres more or less and bounded by the Land of the
said Rich^d H Branch and the Land of the said Albrigton Bradshaw being a part of the old
Somers Bradshaw tract together with all the appurtenances whatsoever to the said Land belong-
ing or appertaining or with the same used or enjoyed or accepted reputed taken or known as
part parcel or member thereof or as belonging to the same or any part thereof. To have and to
hold the said tract of Land with the tenements hereditaments and all and singular other the
premises herein before mentioned or intended to be bargained and sold and every part
and parcel thereof with every of their rights unto the said Richard H Branch his heirs and
assigns forever: And the said Albrigton Bradshaw and Martha his wife for themselves and
their heirs the said Land with all and singular the premises and appurtenances before mention-
ed unto the said Rich^d H Branch his heirs and assigns free from the claim or claims of them
their or either of their heirs and of all and every person or persons whatsoever shall will and do
