This Indenture made and executed this 2nd day of May AD One Thousand eight hundred and thirty
 nine Between Jordan Boy and Martha Boy and his wife and Sally Boy and his Mother of the one part and Adams
 Jones of the other part all of the County of Southampton State of Virginia witnesseth That the said Jordan Boy and
 Martha his wife and Sally Boy and his Mother have for and in consideration of the sum of One hundred and thirty
 Three dollars and Thirty eight Cents to them in hand paid the receipt whereof is hereby acknowledged before me
 and I do also acknowledge and confirm and do by these presents bargain and sell alienate and convey unto the
 said Adams Jones his heirs and assigns forever One certain tract or parcel of Land lying and being in George
 Fox County on the west side of the road from Homies to Franklin containing by survey forty eight acres
 and 2 Rods and is bounded as follows beginning at a red oak corner of this tract and Settles Cobb in Baby
 Branch N. E. 68 1/2 rods to the side of Baby Branch being a
 corner to a post oak then the said line N. E. 68 1/2 rods to a red oak a new corner of this tract and
 Jordan Boy and then N. E. 68 1/2 rods along a new line of marked trees between this tract and Jordan Boy and
 to a red oak at the Roads afterward a new corner of this tract and Jordan Boy and then S. 28° E. 66 rods
 along the said Roads to a white oak a corner of this tract and Barn Bowers in Settles Cobb line then up
 the run of a small Branch along a line of marked trees a line between this tract and Settles Cobb the various
 courses thereof of 32 P. to a block gun in the said branch there N. E. 68 1/2 rods to a pine tree N. E. 68 1/2 rods
 a pine there D. N. W. 15 P. to the Beginning. To have and to hold the aforesaid premises with all the reversion
 and reversions remainder and remainders yearly and other rents forever. The said Jordan Boy and Martha his
 wife and Sally Boy and his Mother do for themselves their heirs and assigns hereby warrant and will forever defend the
 aforesaid premises with all the reversion and reversions remainder and remainders yearly and other rents
 unto the said Adams Jones his heirs and assigns free from all the claim or claims demand or demands of
