Upon the following trust and confidence that is to say that if the said Henry Hindress his execs or admr shall fail to pay or cause to be paid and discharged the bonds aforesaid when they become due it shall be lawful for the said L R Edwards (or in case of his death for his legal personal representative who is hereby authorized to act) being thereto required by the said Butts his execs admr or apigns to make sale of the aforesaid tract or parcel of land and promises to the highest bidder for each having bid on the day and place of sale at his own discretion and given reasonable public notice thereof and out of the monies arising from said sale after defraying the cost and expences of said sale the conveyance paid and discharged the bonds aforesaid or so much of them as may be due and the balancer if any pay over to the said Henry Hindress his execs admr or apigns.
