This Indenture made the 30<sup>th</sup> day of April in the year of one thousand eight hundred  
and thirty nine between Allen Edwards and Eliza his wife of the one part and Patrick Rowe  
of the other part. Witnesseth that the said Allen Edwards and Eliza his wife in consideration  
of the sum of two hundred dollars of lawfull money of this Commonwealth to them in  
hand paid by the said Patrick Rowe at or before the sealing and delivery of these presents  
(the receipt whereof is hereby acknowledged) have bargained and sold and by these presents  
do and each of them doth bargain and sell unto the said Patrick Rowe his heirs and  
assigns a certain tract or parcel of Land containing one hundred and eighteen acres to  
the same more or less and bounded as follows to wit. Beginning at a pine a corner  
the said Land and Rebecca Rowe thence a line of marked trees North West to a pine  
a corner between the said Land and Patrick Rowe and Matthew Wells thence South  
west to a lightwood post a corner between the said Land and Matthew Wells and  
Shadrack Cobb do & thence down down a small branch to the swamp thence down  
the swamp to a Pond a corner tree between the said pond and Lewis Allman  
and Rebecca Rowe thence a line line of marked trees East to the beginning together  
with all and singular houses dove houses barns buildings stables yards gardens  
orchards land tenements meadows pasture feedings common woods <sup>underwood</sup>  
warp waters water courses fishing privileges profits assignments commodities & appurtenances  
hereditaments and appurtenances to the said tract of land belonging or appertaining
