This Indenture made the 24th day of August 1839 between Lilliton R Edwards of the first part, William S Goble and Nicholas M Goble of the second part, and Thomas L Jones and James H Goble of the third part. Whereas the said Thomas L Jones and James H Goble on the day of March 1839 in order to indemnify and secure the said William S Goble and Nicholas M Goble against loss and injury as their security in sundry cases did by Indenture of that date convey to the said Lilliton R Edwards his heirs and assigns among other things a certain house and lot situate in the Town of Jerusalem designated No 17 also a piece or parcel of land & improvements thereon situate in the said Lot No 17 and known as The Noble Lot supposed to contain three acres more or less which said House & lot and piece or parcel of land was purchased by the said Thomas L Jones & James H Goble of John D Hurt. Upon certain trust therein mentioned as will more fully appear by reference to the said Deed of record in the Probate office of Southampton County. And whereas it is now agreed between the parties that the House and lot and piece or parcel of land herein above described shall be released unto the said Thomas L Jones & James H Goble. Now this Indenture witnesseth that in consideration of the premises and for the further consideration of the sum of one dollar in hand paid by the said Thomas L Jones & James H Goble to the said Lilliton R Edwards the receipt whereof is hereby acknowledged by the said Lilliton R Edwards with the approbation of the said William S Goble and Nicholas M Goble declared by their being parties to the premises and the said William S Goble and Nicholas M Goble do by these presents grant bargain sell release and confirm unto the said Thomas L Jones & James H Goble all the estate then and interest both in Law and equity which the said Lilliton R Edwards William S Goble & Nicholas M Goble have and possess in and to the said House and lot & piece or parcel of land and its appurtenances and privileges conveyed by the aforesaid deed of Trust. To have and to hold the said House & lot & piece or parcel of land aforesaid to them the said Thomas L Jones & James H Goble their heirs & assigns forever. And the said Lilliton R Edwards William S Goble & Nicholas M Goble for themselves their respective heirs Executors & assigns that they covenant with the said Thomas L Jones & James H Goble their heirs and assigns that they the said Lilliton R Edwards William S Goble & Nicholas M Goble and their respective heirs Executors & assigns will & shall forever warrant & defend the same to the said Thomas L Jones & James H Goble their heirs and assigns against the claims or claims of themselves respectively and of all and every person claiming by through or under them or either of them but against no other person.
