appoint Elston M. Smith of the aforesaid County and State our true and lawful attorney for us and in our
names and for our use and benefit to ask and demand sue for recover and receive of and from Henry
Pittway of Southampton County and State of Ala or any other person who has in trust certain
slaves to wit: Steven May and her child Peggy for us and our childrens benefit all such sums or
sums of money that may be due or become due for the hire of the said slaves and their increase
which are now due and owing to us the said C. & P. Smith by and from the aforesaid H.
Pittway or any other persons or persons that the same may be due from and also to receive the said
slaves and their increase and to have use and take all lawful ways and means in our names
or otherwise for the recovery thereof by attachment arrest distress or otherwise and to compound
arbitrate and agree for the same and acquittances or other sufficient discharges for the same for
us and in our names to make seal and deliver and to do all lawful acts and things
whenever concerning the premises as fully and in every respect as if we ourselves might or could
do were we personally present and we furthermore authorize and empower the aforesaid Elston
Smith to appoint and attorney for the purposes aforesaid to make and again at our pleasure
